For each factor, enter your score. To earn points in a category, you must meet all the conditions.

Factor One: Education

Note: If you have studied less than the number of years listed with your highest educational credential, you must award yourself the points that match your years of study.

Example 1: If you have a Masters Degree but have completed only 15 years of full-time study, award yourself 22 points.

Example 2: If you have a three or four-year Bachelor's degree, and at least 14 years of education, award yourself 20 points.

Factor Two: Age

You will be awarded points based on your age at the time Prince Edward Island Provincial Nominee Program Office receives your application.

Factor Three: Official Languages

The ability to communicate and work in one or both of Canada's official languages is very important. You will be awarded up to 24 points for your basic, moderate or high abilities in English and/or French. You will be given points based on your ability to listen, speak, read, write and understand.

Definitions

High Proficiency:

The principal applicant can communicate effectively in a range of social and employment situations. The principal applicant can communicate in a professional situation.

Moderate Proficiency:

The principal applicant can communicate reasonably well in relation to familiar situations, such as in the area of professional expertise and personal settings.

Basic Proficiency:

The principal applicant has only minimal knowledge and can only speak, write or read a few words. The principal applicant would require language training.

No Proficiency:

The principal applicant has no knowledge of the English or French language.
